## 17<sup>th</sup> Commemoration of the 1994 Tutsi Genocide in Rwanda

RWANDA

IBUKA

*Never forget that this has happened.  
Remember these words.  
Engrave them in your hearts,  
When at home or in the street,  
When lying down, when getting up.

Or may your houses be destroyed,  
May illness strike you down,

1994 - 2011. 17 years have already passed since over 1 million people (men, women, infants, children and the elderly without distinction) were massacred throughout Rwanda over a period of no more than 100 days simply because they were Tutsis.

The genocide of the Tutsis in Rwanda was the last genocide of the 20th century. Having been planned well in advance and orchestrated by 'Hutu Power', this most heinous of crimes against humanity was committed in the shadow of international diplomacy and against the backdrop of the struggle between western countries for ascendancy in the African Great Lakes Region.

While a number of these countries and the UN have gone some way to recognising their share of responsibility for the genocide of the Tutsis, very little action of substances has been to secure redress for surviving victims, who are continuing to suffer the consequences in many different ways as a result of attempts to negate and trivialise the gravity of this crime and conceal the true nature of the horrors inflicted, not to mention numerous attempts by the perpetrators themselves to shift the blame and conceal evidence in the hope that the genocide of the Tutsis will be forgotten.

It is therefore essential that the memory of the genocide of the Tutsis should not be extinguished and that the flame be kept alive to remind humanity that, despite the fine resolutions and speeches which followed the genocides of the Armenians and Jews, another such act occurred. If future generations are to be taught the value of human life, it is of paramount importance to keep this memory alive and make suitable preparations to prevent or to curb any attempted genocide or genocidal act, while doing everything possible to stiffen the resolve of the surviving victims.

It is for this reason that the IBUKA is organising the 17th commemoration of this event which it invites you to attend in order to help keep the memory alive.
